They are going to jet North Street from Buckleys to East and East from North to the School. #2 pump is here. It will be installed April 1 and should take about 3 days. Derick is doing a lot of GIS mapping of our systems.
- Mayor's Report. Mayor Luedke informed the Board that the Village has purchased the property on Rt. 48. Closing will be the 1st week of April. Desks will be delayed because Ron had an accident with a table saw. Trustee Barker is in the hospital in Springfield. Mayor Luedke talked to Matt Foster about getting our MFT program submitted.
